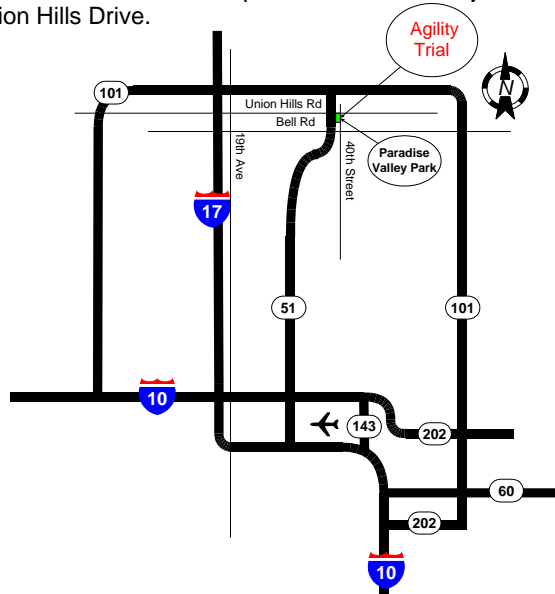

➤ The Judges are not VMO at this trial. If you indicated your dogs need to be measured, it will be on list provided to the judges. If needed, it is **YOUR** responsibility to be measured before your first run.
