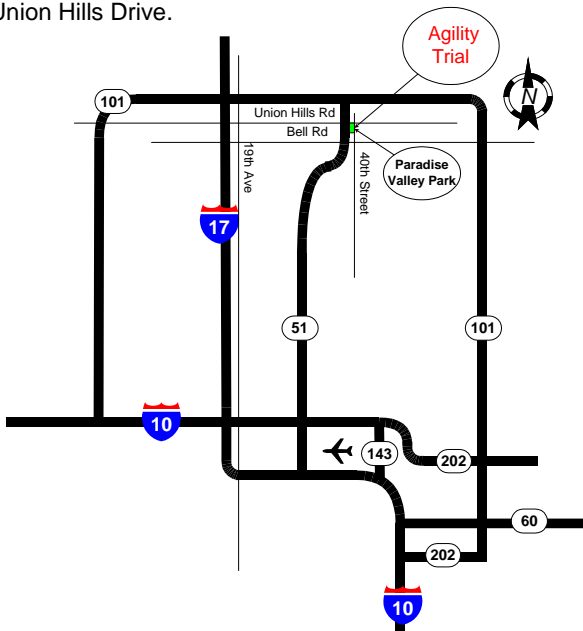
Time 2 Beat – multiple walk throughs as needed

JUMP HEIGHT CARD

- Exhibitor is responsible for carrying their AKC Jump Height Card with them in order to present the card upon request. If you do not have a permanent or temporary AKC Agility Jump Height Card, it is YOUR responsibility to get measured by the AKC Volunteer Measurer Official (VMO) when they are present at a trial.

- Both judges are official VMOs at this trial. The judges will measure between classes. If you indicated your dogs need to be measured, it will be on list provided to the judges. It is YOUR responsibility to be measured at this trial.
