dogs that have not been officially measured for an Agility Jump Height Card may still compete; vever, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer asuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have ir doa(s) measured prior to running.

gs listed in the AKC Canine Partners Program may be eligible to enter all-breed AKC agility trials at club's option. These dogs should be listed as All American Dog and must include their AKC number on entry form and check the AKC No. box.

nior Handlers should enter their Junior Handler number on the front of this form. Should vou not have ur Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
